
## RE-ASSIGNMENT OF MORTGAGE AND RE-ASSIGNMENT OF RENTS



KNOW ALL MEN BY THESE PRESENTS, that Firstmark Leasing Corp., a Delaware corporation (hereinafter "Firstmark Leasing"), in consideration of the sum of Ten Dollars and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby sell, assign, transfer and set over to Firstmark Credit Corporation, an Indiana corporation (hereinafter "Firstmark Credit"), that certain Mortgage dated March 30, 1972, from Illinois Adjustment Company, a corporation, in favor of North West Federal Savings and Loan Association of Chicago, recorded in the Office of the Recorder of Cook County, Illinois as document No. 21 877 836, and that certain Assignment of Rents for Corporation recorded in the Office of the Recorder of Cook County, Illinois, as document No. 21 877 837, together with all of Firstmark Leasing's right, title and interest in and to (a) the promissory note therein described in the principal amount of \$450,000.00, accrued interest and other obligations secured thereby and payable in accordance therewith, and (b) the following real estate, described therein:
