PARTIAL RELEASE DEED

KNOW ALL MEN BY THESE PRESENTS, that Harris Trust and Savings Bank, an Illinois banking corporation, in consideration of one dollar, and other good and valuable consideration, the receipt whereof is hereby acknowledged, does hereby release to Matteson Richton Bank, as Trustee under Trust Agreement dated October 16, 1985 and known as Trust Number 741019 all the right, title, interest, claim or demand whatsoever it may have acquired in, through or by that certain Mortgage and Security Agreement with Assignment of Rents dated October 9, 1986 and recorded October 10, 1986 as Document No. 86470218 (the "Mortgage") in the premises described below, situated in the County of Cook, State of Illinois, as follows, to-wit:

Unit 7006-4 in the Glens of Schaumburg Condominium as delineated on a survey of the following described real estate: Part of the West 7/8 of the Northwest 1/4 of Section 32, Township 41 North, Range 10 East of the Third Principal Meridian which survey is attached as an exhibit to the Declaration of Condominium recorded as Document Number 86-243609 together with its undivided percentage of interest in the common elements in Cook County, Illinois.

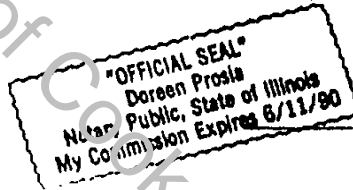
