

- 5. AFFIDAVIT OF INCORPORATION: The corporation became incorporated under the Religious Corporations Act of 1872 by filing an affidavit of incorporation with the Cook County Recorder's Office. A certified copy of the affidavit of incorporation and certified copies of all amendments thereto, consisting of three subsequent affidavits of change of name, are attached.
- 6. ELECTION TO ADOPT ACT: The corporation has elected to accept the General Not For Profit Corporation Act of 1986. A verified copy of the resolution of the Board of Trustees recommending that the corporation accept the Act and directing that the question of acceptance be submitted to a vote at a meeting of the members is attached. The corporation owes no fees, taxes or penalties to the State of Illinois under the Religious Corporations Act of 1872, to which the corporation has previously term subject. The corporation was not required to file any reports.
- 7. MEMBERS' MEETING VHIRE ELECTION MADE TO ACCEPT ACT: The election to accept the Act was made at a meeting of the voting members of the corporation on October 18, 1987. A quorum of voting members was present at the meeting and the acceptance of the Act was in compliance with the corporation's constitution and bylaws, and such acceptance was authorized by the affirmative vote of at least two-thirds of the votes present and voted either in person or by proxy.
- 8. COMPLIANCE WITH CONSTITUTION AND BYDAYS: The corporation followed the requirements of its constitution and bylaws so far as applicable in effecting the acceptance of the General Not For Profit Corporation A.t of 1986.

STATEMENT OF CORPORATE PURPOSES OF HOMEWOOD FULL GOSPEL CHURCH

The purposes of the corporation are as follows:

The corporation is organized and shall be operated exclusively for religious, charitable, or educational purposes within the meaning of \$501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States internal revenue law) (the "Internal Revenue Code"). In the course of which operation:

- (1) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any private shareholder or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein;
- (ii) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office except as authorized under the Internal Revenue Code;
- (iii) Notwithstanding any other provisions of these by-laws, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under \$ 501(c)(3) of the Internal Revenue Code, or by a corporation, contributions to which are desactible under \$ 170(c)(2) of the Internal Revenue Code.
