

Margins of all other sectors (e.g., agriculture, construction, transportation, and utilities) are considerably lower than those of the retail trade, while intermediate goods production, the services of government, and the financial sector have the highest margins.

The number of efficient, voluntary, three member boards has increased from 71,160 in 1970 to 115,179 in 1979. During this period, the percentage of boards which have adopted bylaws has increased from 50% to 75%. The percentage of three member boards which have adopted bylaws has increased from 25% to 50%.
