Under the Internal Revenue Code, the Internal Revenue Service has the authority to issue a Certificate of Release of Tax Lien for a taxpayer who is delinquent in the payment of taxes. This certificate is issued to the taxpayer upon payment of the delinquent taxes and interest. It is not a release of the taxpayer's liability for the taxes, but it is a release of the Internal Revenue Service's lien against the taxpayer's property.

IMPORTANT - PLEASE READ!!
 It is the taxpayer's RESPONSIBILITY to have the Certificate of Release of Tax Lien recorded in the Public Office (County Clerk or Recorder) in order to ensure that the Release will have the effect of releasing the taxpayer's property from the Internal Revenue Service's lien.
