

#### Excerpts From Internal Revenue Gode

#### Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount including any inforest, additional amount, addition to lax, or assessable penalty, together with any costs that may accue in addition therato) shall be a lien in layer at the United States upon all property and rights to property; whether real or personal, belonging to such person.

### Sec. 6322. Period of Lien.

Unless another thate is specifically treed by law, the dien imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so excessed (or a judgment against the taxpayer arising out of such Hability) is settified or becomes unenforceable by reason of lapse of time.

### Sec. 6323. Validity and Priority Against Certain Persons.

- (a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors. The lien imposed by section 6321 shall not be valle as against any purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice (heteol which meets the sequirements of subsection (i) hyposen titled by the Secretary
- (b) Protection For Certain interests Even Though Notice Filed, Even though notice of a fien imposed by sector, 6321 has been filed, such flow shall not be walled.

#### (i) Place For Filing Notice; Form. -

- (1) Place for filing. The notice referred to in subsection (a) shell be filed. (21), (1)
  - (A) Under State Laws.-
  - (i) Real Property. in the case of real property, in one office within the State (or the county, or other povernmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated and

- (B) Person Property. In the case of paragraph property, the list tangible or intangible, at the residence of the tangerer at the time the natice of then is filed.

For purposes of paragriph () (B), the residence of a corporation or distinctible shall be deemed to be the place at which the principal executes office of the business; is located, and the residence of a taxpeyer whose residence to without the United States of all to deemed to be in the District of Columbia.

- (p) Refilling Of Notice. for purposes of this section -
- (1) General Rule. Unless notice of tien is reflied in the manner prescribed in paragraph (2) during the cequired rutiling period, such notice of tien shall be troated as filed on the date on which it is filed (in accordance with subsection (f)) after the expiration of such retiling period.
- (2) Place For Filing. A notice of then refiled during the required refiling partial shall be effective only.

- (2) Bond Accepted. There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment of the amount assessed, together with all interest in respect thereof, within the time prescribed by the (including any extension of such time), and that is in accordance with such requirements relating to terms, conditions, and form of the bond and sureties thereon, as may be specified or such requirements.
