1. That there is on the premises commonly known as 149-51 West 72nd Street/ 7200-06 South Vincennes, Chicago, Illinois, a 3 story building with bsmt. & attic w/ 12 d. units legally described as Lots 2 to 7, Block 15, in Eggleston's 2nd Sub of the N 1/2 of the NE 1/4 of section 28, township 38 North, Range 14 lying East of the third principal meridian in Cook County, IL.

2. That the aforesaid premises fails to conform in certain instances to the minimum standards of health and safety of the ordinances of the CITY OF CHICAGO, a Municipal Corporation, as set forth in the Plaintiff's verified complaint.

WHEREFORE, IT IS HEREBY ORDERED THAT the Defendant(s) Newman Associates, their successors, agents and assigns

be and is (are) hereby permanently enjoined and restrained from using, renting, leasing occupying until heat is restored
