

LOAN MODIFICATION AGREEMENT

This Modification Agreement made as of the 8th day of December, 1986, between ORLAND PARK PLAZA BANK, hereinafter called "Bank", and AMALGAMATED TRUST & SAVINGS BANK as Trustee under a Trust Agreement dated January 24, 1983 and known as Trust No. 4783 and not personally, hereinafter referred to as "Borrower";

WHEREAS, Borrower executed a Note dated as of January 27th, 1983 evidencing a debt of Forty Four Thousand Eight Hundred Dollars and no/100 (\$44,800.00);

IT IS HEREBY AGREED that the outstanding principal balance of other Note will be reduced by \$4,000.00 upon execution of this Agreement.

IT IS HEREBY AGREED that, affective January 1, 1987, the interest rate stated in the Note is modified to 10.5% from 15.25% per annum.

IT IS FURTHER AGREED that effective January 1, 1987, the monthly payments stated in the Instalment Note are modified to \$540.05 from \$582.52.

IT is FURTHER AGREED that all other terms of the Note and Mortgage previously executed by Borrower and more fully identified above, not inconsistent with the matters contained in this Loan Modification Agreement shall be unchanged and remain in full force and effect.

This Agreement is signed by AMALGAMATED TRUST & SAVINGS BANK, not individually but solely as Trustee under a certain Trust Agreement known at Trust No. 4783. Said Trust Agreement is hereby made a part hereof red any claims against said Trustee which may result from the signing of this Agreement shall be payable only out of any trust property which may be held thereunder, and said Trustee shall not be personally liable for the performance of any of the terms and conditions of this agreement or for the validity or condition of the title of said property or for any agreement with respect thereto. Any and all personal liability of AMALGAMATED TRUST & SAVINGS BANK is hereby expressly waived by the parties hereto and their respective successors and assigns.

WHEREFORE, this Loan Modification Agreement is executed as of the day and date set forth above.

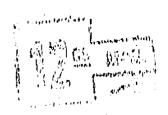
