MORTGAGE MODIFICATION AGREEMENT

Agreement made as of December 31, 1986 by and between the First National Bank of Winnetka, not personally but as Trustee under Trust Agreement dated February 27, 1978 and known as Trust No. 780 ("Trust"); First Illinois Bank of Evanston, N.A. ("Bank"); and Richard N. Hochschild, Bruce Dean Gardner, Roland Bodinus, Richard A. Craig, Danilee Craig; and John H. Winand (collectively "Guarantors").

RECITALS

- Trust is indebted to Bank in the original principal sum of Two Hundred Α. Forty Eight Thousand Dollars (\$248,000.00) as evidenced by a Mortgage Note ("Note") dated as of August 28, 1984, which Note is secured in part by a Mortgage, Security Agreement and Financing Statement ("Mortgage") and Assignment of kents applicable to the property commonly known as 319-321 Custer, Evanston, Limois, legally described on Exhibit A attached hereto, which documents were recorded with the Cook County Recorder of Deeds on September 19, 1984 as Locument numbers 27259437 and 27259438 respectively.
- Said Note is also secured by the joint and several Guaranty of Payment 8. dated as of August 28, 1984 executed by the Guarantors.
- The present principal balance of the Note is Two Hundred Forty Six Thousand Ç. Six Hundred Thirty Seven and 89/100 Pollars (\$246,637.89).
- Trust and Guarantors have requested an adjustment to the interest rate and D. extension to the maturity of the Note and the Bank is willing to grant such request.

NOW, THEREFORE, in consideration of the above Recitals, the parties hereto do hereby acknowledge and agree as follows:

- Concurrent with the execution of this Agreement, the Trust, at the direc-1. tion of the beneficiaries (Guarantors) of the Trust, shall execute and deliver a replacement Mortgage Note, which shall provide for a maturity date of December 31, 1988 and bear interest at the rate of nine percent (9%) per annum.
- The new Note shall continue to be secured by the Mortgage and Assignment of 2. Rents referred to above.
- Guarantors do hereby reaffirm and ratify their guaranty. 3.
- Bank shall be entitled to and shall receive a service fee equal to 1% of the present principal balance due under the Note in consideration for execution of this Agreement.
