or its agents, due or to become due, or that may hereafter be contracted, and also to the payment of all expenses and the care and management of said premises, including taxes and assessments, and the interest on encumbrances, if any, which may be in its judgement deemed proper and advisable.

This instrument is given to secure payment of the principal sum and interest of or upon a certain loan for \$50,921.88 dollars secured by a Mortgage or Trust Deed dated the 6th day of January, 19 87, conveying and mortgaging the real estate and premises hereinabove described to Columbia National Bank of Chicago
