Infelise and Marlene G. Infelise, his wife and, Grantee(s) residing at 304 Ashwood Drive, Valerie A. Infelise, a spin-Schaumburg, Illinois 60193 the following described real estate situated in the County of Cook in the State of Illinois, to-wit:

Unit 23-3 in The Fox Run Manor Homes Condominium, as delineated on a survey of the following described real estate: Part of the Northeast 1/4 of Section 26, Township 41 North, Range 10, East of the Third Principal Meridian, in Cook County, Illinois, which survey is attached as Exhibit B to the Declaration of Condominium recorded as Document No. 27469146, together with its undivided percentage interest in the common elements, in Cook County, Illinois.

TO HAVE AND TO HOLD such real estate unto the Grantee(s) forever, not in tenancy in common, but in joint tenancy.
