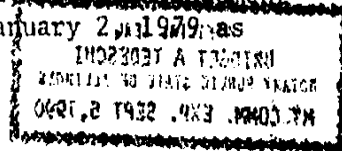
## RELEASE DEED

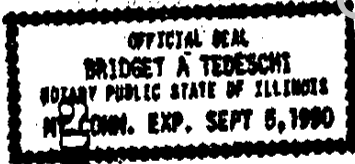
