

EXHIBIT "A"

That part of the East half of the South East quarter of Section 22, Township 41 North, Range 11 East of the Third Principal Meridian, described as follows: Commencing at the South East corner of said South East quarter; thence North along the East line of said South East quarter 438.15 feet to the center line of Higgins Road as originally laid out for the point of beginning; thence North-westerly along said center line, being along a line that forms an angle of 41 degrees 11 minutes to the left with the prolongation of the last described course, a distance of 347.45 feet; thence North parallel with the East line of said South East quarter, 331.01 feet to the Southerly line of a 50 foot wide strip of land lying Southerly of the Southerly right of way of the North West Toll Highway; thence Southeasterly along the Southerly line of said 50 foot strip of land 513.73 feet to the East line of said South East quarter; thence South along said East line 376.85 feet to the point of beginning, (except the East 50 feet thereof), in Cook County, Illinois.
