

RELEASE DEED

THIS RELEASE DEED is made January 21, 1987, by METROPOLITAN BANK AND TRUST COMPANY, an Illinois banking corporation ("the Bank"), 2201 West Cermak Road, Chicago, Illinois 60608.

WHEREAS, by a certain Trust Deed, dated August 12, 1986, and recorded in the Recorder's Office of Cook County, State of Illinois, in Book _____, Page _____, as Document No. 86355626, the premises situated in the County of

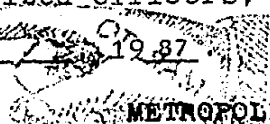
and, WHEREAS, the indebtedness secured has been fully paid, satisfied and discharged,
