AN ORDINANCE PROVIDING FOR THE ANNEXATION OF
CERTAIN REAL ESTATE TO THE VILLAGE OF ORLAND
PARK, COOK COUNTY, ILLINOIS (STANEK)

WHEREAS, there has been heretofore filed with the Village Clerk a Petition requesting annexation of the real estate hereinafter described to the Village of Orland Park, Cook County, Illinois; and

WHEREAS, said real estate is not now within the present corporate territorial limits of the Village of Orland Park, but is contiguous to and adjoining the present corporate territorial limits of the Village of Orland Park; and

WHEREAS, said real estate is not now within the present corporate territorial limits of any city, village or town; and

WHEREAS, all of the electors residing on said real estate have joined in said Petition; and

WHEREAS, it is to the best interests of the Village of Orland Park that said real estate be annexed to the Village of Orland Park in accordance with the provisions of the Statutes of Illinois in such case made and provided.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois, as follows:


SECTION 1

That the material allegations of the annexation Petition above-described heretofore filed with the Village Clerk are true and that said Petition states the matters required to be stated in accordance with the Statutes of Illinois in such case made and provided.

SECTION 2

That the following described real estate, to-wit:

That part of the Southeast 1/4 of the Southeast 1/4 of Section 7, Township 36 North, Range 12 East of the Third Principal Meridian, bounded and described as follows: Beginning at the Southwest corner of the Southeast 1/4 of the Southeast 1/4 of Section 7 aforesaid; thence North 0°59'50" East along the West line of said Southeast 1/4 of the Southeast 1/4 of Section 7, a distance of 251.36 feet to the center of the creek; thence North 86°40'30" East along the center of the creek, 342.66 feet to a point; thence South 69°03'50" East along the center of the creek, 80.61 feet to a point; thence South 67°34'10" East along the center of the creek, 4.29 feet to a point; South 0°59'50" West, a distance of 247.81 feet to a point in the South line of the said Southeast 1/4 of the Southeast 1/4 of Section 7, thence North 89°03'10" West along the said South line of the Southeast 1/4 of the Southeast 1/4 of Section 7, a distance of 470.97 feet, more or less, to the place of beginning, all in Cook County, Illinois, excepting from the above described parcel of land, the South 50.0 feet thereof.

Any highways or parts of highways adjacent to the above described real estate not located within a municipality,

is hereby annexed, added to, taken in and made a part of the corporate territorial limits of the Village of Orland Park, Cook County, Illinois.


SECTION 3

I DO FURTHER CERTIFY that the said Ordinance was delivered to the Village President of the Village of Orland Park after the passage thereof by the said Board of Trustees on the 19th day of January, 1987, by the Village Clerk of the said Village of Orland Park, and that the said Ordinance was approved by the Village President of said Village of Orland Park on the 19th day of January, 1987.
