ORDINANCE NO. 1632

OFFICIAL BUSINESS VILLAGE OF ORLAND PARK, BL BAYMOND W. PIEFER VILLAGE ATTORNEY

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN REAL ESTATE TO THE VILLAGE OF ORLAND PARK, COOK COUNTY, ILLINOIS (STANEK)

WHEREAS, there has been heretofore filed with the Village Clerk a Petition requesting ammexation of the real estate hereinafter described to the Village of Orland Park, Cook County, Illinois; and

WHEREAS, said real estate is not now within the present corporate territorial limits of the Village of Orland Park, but is contiguous to and adjoining the present corporate territorial limits of the Village of Orland Park; and

WHEREAS, said real estate is not now within the present corporate territorial limits of any city, village or town; and

WHEREAS, all of the electors residing on said real estate have joined in said Petition; and

WHEREAS, it is to the best incorests of the Village of Orland Park that said real estate be annexed to the Village of Orland Park in accordance with the provisions of the Statutes of Illipois in such case made and provided.


NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois, as follows:

SECTION 1

That the material allegations of the annexation Petition above-described heretofore filed with the Village Clerk are true and that said Petition states the matters required to be stated in accordance with the Statutes of Illinois in such case made and provided.

That the following described real estate, to-wit:

That part of the Southeast 1/4 of the Southeast 1/4 of Section 7, Township 36 North, Range 12 East of the Third Principal Meridian, bounded and described as follows: Beginning at the Southwest corner of the Southeast 1/4 of the Southeast 1/4 of Section 7 aforesaid; thence North 0°59'50" East along the West line of said Southeast 1/4 of the Southeast 1/4 of Section 7, a distance of 251.36 feet to the center of the creek; thence North 86°40'30" East along the center of the creek, 342.66 feet to a point; thence South 69°03'50" East along the center of the creek, 80.61 feet to a point; thence South 67°34'10" East along the center of the creek, 4.29 feet to a point; South $0^{\circ}59'50''$ West, a distance of 247.81 feet to a point in the South line of the said Southeast 1/4 of the Southeast 1/4 of Section 2, thence North 89°03'10" West along the said South line of the southeast 1/4 of the Southeast 1/4 of Section 7, a distance of 4/0.97 feet, more or less, to the place of beginning, all in Cook Courty, Illinois, excepting from the above described parcel of land, the Scati. 50.0 feet thereof.

Any highways or parts of highways adjacent to the above described real estate not located within a municipality,

is hereby annexed, added to, taken in and made a part of the corporate territorial limits of the Village of Orlead Park, Cook County, Illinois.

That the Village Clerk cause a copy of this Ordinance, together with an accurate map of the territory annexed, certified by the Village Clerk, to be recorded with the Recorder of Deeds of Cook County, Illinois, and to be filed with the County Clerk of Cook County, Illinois.
