B.) That the aforesaid sections of the premises be maintained in a vacant and secure condition until further order of this Court.

C.) That the Court Ordered Relocation Service of the Department of Human Services be and is hereby directed to assist in the relocation of those persons affected by this Order.

D.) That defendants, their agents, employees and attorneys, be and are hereby enjoined from interfering with the representatives of the Court Ordered Relocation Service in effectuating the terms of this Order.

E.) That the defendants maintain all utilities, including but not limited to electricity, water, gas and heat to those sections of the subject premises
