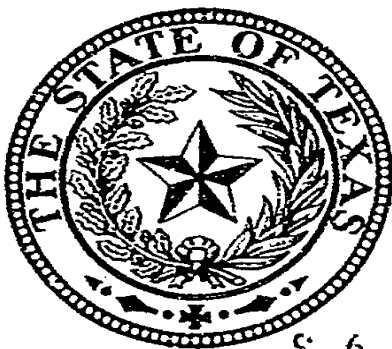

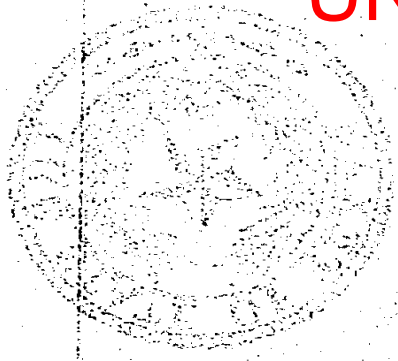

11. 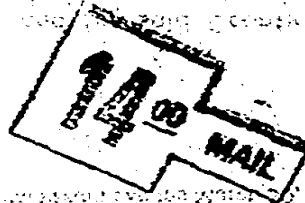
