THIS INDENTURE WITNESSETH: That the undersigned, First Illinois Bank of Evanston, N.A. (fas First National Bank and Trust Company of Evanston) as Trustee under Trust of the City of Evanston Cook State of Illinois, hereinafter referred to County of ____

THE MORTGAGOR COVENANTS:
