## EXTENSION AND MODIFICATION AGREEMENT

THIS AGREEMENT Made this 5th day of January, 1987 by and between John H. and Judith C. Alberta

AND WHEREAS SAID Trust Deed securing said Principal Promissory Note is a valid and subsisting lien on the premises described therein.

AND WHEREAS the parties hereto have agreed upon certain modifications of the terms of said Note and Trust Deed, and to an extension of the time of payment of said Note.

NOW, THEREFORE, in consideration of the premises, and the mutual promises and agreements hereinafter made by and between the parties hereto, the said parties do hereby mutually agree as follows: That said Trust Deed be and the same is hereby modified to show the next payment due on the fifth day of February, 1987, with the final payment, if not sooner paid, due on the fifth day of January, 1991, with monthly payments of \$870.80 \*\* including principal and interest at the rate of 10.00 percent per annum.

IT IS FURTHER MUTUALLY AGREED BY AND BETWEEN THE PARTIES THAT ALL PROVISIONS OF said Note and Trust Deed shall remain unchanged and in full force and effect for and during said extended period except only as herein specifically modified, and further that in the event of default in the payment of principal or interest due under said Note as herein modified, or in the event of failure to perform any
