

Unit 3-2U, as delineated on the survey of the following described parcel of real estate. That part of the West 1/2 of the North West 1/4 of Section 23, Township 37 North, Range 12, East of the Third Principal Meridian, Cook County, Illinois, lying Northwesterly of the North Reserve Line of the Calumet Sag Feeder Canal and lying Easterly of the East line of a 50 foot wide strip dedicated for Highway purposes by Document Number 10,627,385 described as follows: Beginning at a point on the East line of the 50 foot strip dedicated for Highway purposes by Document Number 10,627,385, said point being 465.00 feet South of the North line of the aforesaid North West 1/4 of section 23; thence East along a line parallel with the North line of the North West 1/4 of aforesaid Section 23, 31.00 feet; thence North along a line parallel with the East line of the 50 foot strip, 165.00 feet; thence East along a line parallel with the North line of the North West 1/4 of Section 23, 90.67 feet; thence North along a line parallel with the East line of the 50 foot strip, 32.50 feet (said point being 267.50 feet South of the North line of the North West 1/4 of Section 23); thence East parallel to the North line of the aforesaid North West 1/4 of Section 23, 116.00 feet; thence South along a line parallel to said East line of the 50 foot strip, 43.38 feet; thence Southeasterly along a line forming an angle of 42 degrees 10 minutes turned to the left from the prolongation of the last mentioned course, a distance of 57.04 feet to the Northwestern Reserve Line of the Calumet Sag Feeder Canal; thence Southwesterly along the Northwestern Reserve Line of the Calumet Sag Feeder Canal to a point on the East line of the 50 foot strip dedicated for Highway purposes, said point being 165.22 feet South of the Place of Beginning; thence North along said East line of the 50 foot strip, 165.22 feet to the Place of Beginning which survey is attached as Exhibit "A" to Declaration of Condominium Ownership made by FORDCITY BANK, as Trustee under Trust Number 985, recorded in the Office of Recorder of Cook County, Illinois, as document number 23,110,304, together with an undivided 5.05% interest in said Development Parcel (excepting from said Development Parcel all the property and space comprising all the units thereof as defined and set forth in said declaration and Survey).
