(2) **Silva Of Property Subject To Lien.** — For purposes
of paragraph (1) and (2) property shall be deemed to be situated
(A) **Real Property.** — In the case of real property, at all
times prior to the date of
(B) **Personal Property.** — In the case of personal property,
whether tangible or intangible, at the residence
of the taxpayer at the time the notice of lien is filed.

For purposes of paragraph (2) (B) the residence of a corpora-
tion or partnership, it is deemed to be the place at
which the principal business office of their business is
located, and the residence of a taxpayer whose residence
is without the United States and is deemed to be in the
District of Columbia.

(3) **Form.** — The form and content of the notice referred to in subsection (a) shall be prescribed by the Secretary. Such notice shall be valid notwithstanding any other provision of law regarding the form or content of a notice of lien.

(g) **Delivery Of Notice.** — For purposes of this section—

(1) **General Rule.** — Unless notice of lien is filed in the manner prescribed in paragraph (2) during the required retilling period, such notice of lien shall be treated as filed on the date on which it is filed (in accordance with subsection (f)) after the expiration of such retilling period.

(2) **Place For Filing.** — A notice of lien filed during the required retilling period shall be effective only—

(A) if—
(i) such notice of lien is filed in the office in
which the prior notice of lien was filed; and

(ii) in the case of real property, the fact of
retilling is entered and recorded in an index to
the extent required by subsection (f) (4); and

(B) in any case in which 60 days or more prior to the
date of a retilling of notice of lien under subparagraph
(A) the Secretary receives written information (in the
manner prescribed in regulations issued by the Secretary)
concerning a change in the taxpayer's residence, if a
notice of such lien is also filed in accordance with sub-
section (f) in the State in which such residence is located.
