Bank shall not be required to commence proceedings squinst such successor or refuse to extend time for payment or otherwise modify by reason of any demand made by the original Borrower and Borrower's successors in interest.
- 10. O' con arance by Bank Not a Waiver. Any forbearance by Bank in exercising any right or remedy under the Agreement hereunder, or otherwise a to; ded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy. The procurement of insurance or the payment of taxes or other liens or charges by Bank shall not be a waiver of Bank's right to accelerate the maturity of the indebtedness secured by this Morniaga.
- 11 Successors and Assign's Bound: Joint and Several Liability: Captions. #### RIDER TO EQUITY CREDIT LINE MORTGAGE

This Rider is made as of the <a href="16th">16th</a> day of <a href="January">January</a>, 1987, and is attached to and made a part of that certain Equity Credit Line Mortgage of even date herewith granted by the undersigned (the "Borrower") to The Northern Trust Company (the "Bank").

- 23. Notwithstanding anything to the contrary in Section 19 of the Equity Credit Line Mortgage or in the Agreemen', the Bank shall notify the Borrower at least 30 days prior to listituting any action leading to repossession or foreclosure (except in the case of the Borrower's abandonment the Property or other extreme circumstances).
- 24. If the Borrower has paid any precomputed finance charge, upon the Borrower's payment of the entire outstanding principal balance and cermination of the Equity Credit Line, the Borrower shall be entitled to a refund of the unearned portion of such prepaid finance charge in an amount not less than the amount that would be calculated by the actuarial method, provided that the Borrower shall not be entitled to any refund of less than \$1.00. For the purposes of this Section 24, the term "actuarial method" shall mean the method of allocating payments made on a debt between the outstanding balance of the obligation and the precomputed finance charge pursuant to which a payment is applied first to the accrued precomputed finance charge and any remainder is subtracted from, or any deficiency is added to the outstanding balance of the obligation.
