NOTE AND MORTGAGE AMENDMENT

THIS AMENDMENT is given on January 31, 1987, between the Mortgagor, American National Bank and Trust Company of Chicago, U/T/N 41133 ("Borrower") and Continental Illinois Bank-South Suburban, formerly The First Suburban Bank of Olympia Fields ("Lender") a Corporation located at 20900 South Western Avenue, Olympia Fields, organized and existing under the laws of the State of Illinois.

- 3) To fully amortize the Indebtedness by the maturity date of December 1, 2001.
