THIS INDENTURE, Made December 17, 1986, between Citizens Bank & Trust Company, an Illinois Banking Corporation, not personally but as Trustees under the provisions of a Deed or Deeds in trust duly recorded and delivered to said Bank in pursuance of a Trust Agreement dated August 18, 1986 and known as trust number 66-5445, herein referred to as "First Party," and

an Illinois corporation herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS First Party has concurrently herewith executed an instalment note bearing even date here-

Debtors on the first day of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the first day of February, 1988. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each instalment unless paid when due shall bear interest at the rate of seven per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in Park Ridge Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of CITIZENS BANK & TRUST COMPANY, 1 S. Northwest Highway, Park Ridge, Illinois/ 60068 in said City.

NOW, THEREFORE, First Party to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, does by these presents grant, remise, release, alien and convey unto the trustee, its successors and assigns, the following described Real Estate situated, lying and being in the COUNTY OF Cook AND STATE OF ILLINOIS, to wit:

which, with the property hereinafter described, is referred to herein as the "premises."

TOGETHER with all improvements, tenements, easements, fixtures, and appurtenances thereto belonging, and all rents, issues, and profits thereof for so long and during all such times as First Party, its successors or assigns may be entitled thereto which are plied primarily and on a parity with said real estate and not secondary, and all apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, window light, power, refrigeration, whether single units or centrally controlled, and ventilation, including (without restricting the foregoing), screens, window shades, storm doors and windows, floor coverings, indoor beds, armoires, stoves and water heaters. All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by First Party or its successors or assigns shall be considered as constituting part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever for the purposes, and upon the uses and trusts hereinafter set forth.

IT FURTHER UNDERSTOOD AND AGREED THAT

- I. Until the indebtedness aforesaid shall be fully paid, and in case of the failure of First Party, its successors or assigns to: (i) promptly repair, restore or rebuild any damaged improvements now or hereafter on the premises which may become damaged or be destroyed; (ii) keep said premises in good condition and repair, without waste, and free from verminous or other pests or other items or claims for rent not expressly subordinated to the lien hereof; (iii) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee, its holders of the note, or complete within a reasonable time any building or buildings now or at any time in process of construction upon said premises; (iv) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (v) refrain from making material alterations in said premises except as required by law or municipal ordinance; (vi) pay before any penalty attaches all general taxes, and special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and upon written request, to furnish to Trustee or to holders of the note duplicate receipts therefor; (vii) pay in full under protest, in the manner provided by statute, any tax or assessment which First Party may desire to contest; (viii) keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning or windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable in case of loss or damage, to Trustee for the benefit of the
