To further secure the obligation, the Grantors agree to deposit with the Trustee, as noteholder, on the First day of each month, commencing January 1, 1970, until the indebtedness hereby secured shall have been fully paid, an amount equal to one-twelfth of the annual real estate taxes, special assessment levies and property insurance premiums. Said sums shall be held by the Trustee, as noteholder, without any allowance of interest, for application toward payment of taxes, special assessment levies and insurance premiums when due, but the Trustee, as noteholder, shall be under no obligation to ascertain the correctness of or to obtain the tax, special assessment levies or insurance bills, or attend to the payment thereof, except upon presentation of such bills. The Grantors further agree to deposit within 10 days after receipt of demand therefor any deficiency in the aggregate of such monthly deposits in the event the tax, special assessment levies or insurance bills when issued shall be in excess thereof. If the funds so deposited cover the amount required to pay such taxes and assessments (general and special) for any year, the excess shall be applied on a subsequent deposit or deposits. In event of a default in any of the provisions contained in this trust deed or in the note secured hereby, the holder of the note may at its option, without being required to do so, apply any moneys at the time on deposit on any of Grantor's obligations herein or in the note contained in such order and manner as the holder of the note may elect. When the indebtedness secured hereby has been fully paid, any remaining deposits shall be paid to Grantor or to the then owner or owners of the mortgaged premises.

The note secured by this Trust Deed is subject to prepayment in accordance with the terms thereof. The principal note secured by this trust deed bears the following endorsement: "Section 6 - The payments herein required, the maturity of the within note, and the right, option and privilege of paying One Hundred and Ninety Dollars (\$190), or any multiple thereof, without premium, bonus, or penalty, or any monthly payment date, any amount so prepaid to be applied on the then last maturing principal installment."
