That part of the Southeast quarter of Section 12, Township 42 North, Range 10 East of the Third Principal Meridian, in Cook County, Illinois, described as follows:

Commencing at the Southeast corner of the Southeast Quarter of Section 12 aforesaid; thence on an assumed bearing of North 00 degrees 00 minutes 00 seconds East

716.16 feet to the centerline of U.S. Route 12 (Rand Road); thence North 43 degrees 51 minutes 30 seconds West along said centerline of Rand Road, 638.71 feet; thence South 46 degrees 05 minutes 22 seconds West along a line which intersects the South line of the Northeast Quarter of the aforementioned Southeast Quarter of Section 12 at the Southwest Corner of said Northeast Quarter, 50.00 feet for a point of beginning; thence continuing along the last described course, 253.84 feet; thence North 29 degrees 54 minutes 30 seconds West, 128.83 feet to a point on a line hereinafter referred to as "line A", which is described as a straight line drawn from a point on the aforementioned centerline of Rand Road, which is 763.71 feet Northwesterly of the intersection of said centerline with the aforementioned East line of the Southeast Quarter of Section 12 aforesaid, to a point on the aforementioned West line of the Northeast Quarter of said Southeast Quarter of Section 12, which is 1147.88 feet South of the Northline of said Southeast Quarter; thence continuing North 29 degrees 54 minutes 30
