AN ORDINANCE AMENDING THE WATER RATES AS PRESCRIBED IN SECTION 68, ARTICLE V, OF ORDINANCE NUMBER 294, PASSED AND APPROVED ON MARCH 20, 1969, AS HERETOFORE AMENDED, AND BEING SUB-SECTION "A", SECTION 4-5-2, CHAPTER 5, TITLE IV, OF THE CRESTWOOD VILLAGE CODE

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Crestwood:

Section One: The rates for water consumption, service, and usage, as prescribed in Section 68, Article V, of Ordinance Number 294, passed and approved on March 20, 1969, as amended (being sub-section "A", Section 4-5-2, Chapter 5, Title IV, of the Crestwood Village Code), are hereby amended to be and read as follows:

A. Water service charges -

1. For single-family residential building users and for school district, park district, public library district, and church users:
 - (a) For the initial 10,000 gallons of water for each three-month quarter of a year, as billed by the Crestwood Water Department and as prescribed by this ordinance. Fourteen (\$14.00) Dollars.
 - (b) For the next 190,000 gallons of water (after the initial 10,000 gallons) for each three-month quarter, each 1,000 gallons shall be at the rate of One and 40/100 (\$1.40) Dollars.

- (c) For water exceeding 200,000 gallons for each three-month quarter, each 1,000 gallons shall be at the rate of One and 30/100 (\$1.30) Dollars.
- (d) The minimum charge for water service for each three-month quarter shall be Fourteen (\$14.00) Dollars for each user.

2. For apartment buildings, computed as follows for each dwelling unit as defined by the building ordinances and zoning code of the Village of Crestwood:

- (a) For the initial 10,000 gallons of water for each month, - each 1,000 gallons shall be at the rate of One and 40/100 (\$1.40) Dollars.
- (b) For the next 190,000 gallons of water (after the initial 10,000 gallons) for each month, - each 1,000 gallons shall be at the rate of One and 40/100 (\$1.40) Dollars.
- (c) For water exceeding 200,000 gallons for each month, - each 1,000 gallons shall be at the rate of One and 30/100 (\$1.30) Dollars.
- (d) The minimum charge for water service for each month shall be Four and 50/100 (\$4.50) Dollars.
- (e) Notwithstanding the foregoing, whenever two or more dwelling units are served by a single water meter, the bracket of use, as established above, shall be multiplied by the number of dwelling units served through the said meter, and the minimum charge per quarter shall be multiplied by the number of dwelling units served.

3. For commercial and industrial users:
- (a) For the initial 10,000 gallons of water for each month, - each 1,000 gallons shall be at the rate of One and 50/100 (\$1.50) Dollars.
 - (b) For the next 190,000 gallons of water (after the initial 10,000 gallons) for each month, - each 1,000 gallons shall be at the rate of One and 30/100 (\$1.30) Dollars.
 - (c) For water exceeding 200,000 gallons for each month, - each 1,000 gallons shall be at the rate of One and 20/100 (\$1.20) Dollars.
 - (d) The minimum charge for water service for each month shall be Five (\$5.00) Dollars.
4. For rest homes, shelter-care facilities, nursing homes, or hospital users:
- (a) For the initial 10,000 gallons of water for each three-month quarter of a year, as billed by the Crestwood Water Department and as prescribed by this ordinance, each 1,000 gallons shall be at the rate of One and 50/100 (\$1.50) Dollars.
 - (b) For the next 190,000 gallons of water (after the initial 10,000 gallons) for each three-month quarter, each 1,000 gallons shall be at the rate of One and 30/100 (\$1.30) Dollars.
 - (c) For water exceeding 200,000 gallons for each three-month quarter, each 1,000 gallons shall be at the rate of One and 10/100 (\$1.10) Dollars.
 - (d) The minimum charge for water service for each three-month quarter shall be Fifteen (\$15.00) Dollars for each user.

5. For residential, apartment, commercial, industrial, rest home, shelter care, nursing home, hospital, school, park, and church users not within the corporate limits of the Village of Crestwood, - the water service charges and rates shall be as indicated in paragraphs "1" through "4", directly above, plus an additional fifty (50%) percent thereof.

6. Water service charges and rates for installations not defined in the preceding paragraphs shall be determined and designated by the Board of Trustees and Mayor upon application for service by a prospective user.

Section Two: The sewer service charges prescribed in sub-section "B", section 4-5-2, Chapter IV, of the Crestwood Village Code, remain unchanged.

Section Three: Any person, firm, or corporation violating the provisions of this Ordinance shall be fined not more than Five Hundred Dollars for each offense; and a separate offense shall be deemed committed on each day during, or on which, a violation occurs or continues.

Section Four: If any section, paragraph, clause or provision of this Ordinance, or the application thereof to any person or circumstance is held invalid, the remainder of this Ordinance, or the application of such section, paragraph, clause or provision to persons or circumstances other than those as to which it is held invalid, shall not be affected thereby.
