THIS INDENTURE made February 28th, 1987 between

NICK GELLIS and BETTY GELLIS, his wife

herein referred to as "Mortgagors," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of \$61,066.32

and delivered, in and by which said Note the Mortgagors promise to pay the sum of \$61,066.32 including interest in instalments as follows:

SEVEN HUNDRED TWENTY-SIX AND 98/100'S----- Dollars or more on the 2nd day of April 1987 and SEVEN HUNDRED TWENTY-SIX AND 98/100'S-- Dollars or more on the same day of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the 2nd day of March 1994.

NOW, THEREFORE, the Mortgagors to secure the payment of the said sum of money in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors, and assigns the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the Oak Lawn COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, Interest, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.
