That said owner, or the agent, architect or superintendent of owner (a) does not upon reasonable diligence, be found in said County, or (b) do not reside in said County.<sup>1</sup>

That said contractor is entitled to credits on account thereof as follows: \$41,055.24

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of \$12,141.05 Dollars, for which, with interest,

the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
