AFFIDAVIT

WHEREAS, THE Village of Northbrook did, by Ordinance No. 87-8, dated February 24, 1987, voluntarily annex the following described contiguous territory in accordance with Article 7, Division 1, Section 1 and Division 1, Section 8 of the Illinois Municipal Code:

Lots 1, 2, 3, 5, 6 and 7 in La Vigne's Acres Subdivision in the Northeast Quarter of the Southwest Quarter of Section 17, Township 42, Range, 12, East of the Third Principal Meridian

and

that part of Lot 4 in La Vigne's Acres Subdivision as aforesaid described as follows: commencing at the Northeast corner of said Lot 4; thence west on the North line thereof 128.78 feet; thence south 50 feet measured perpendicular to said North line; thence Southeasterly 170.50 feet to a point on the South line of said Lot 4 which is 50 feet west of the Southeast corner of said Lot 4; thence 50 feet east along the South line of said Lot 4 to the Southeast corner of said Lot 4; thence north along the East line of said Lot 4 202.2 feet to the place of beginning;

the full right-of-way of Techny Road and La Vigne Lane abutting all said properties, all in Cook County, Illinois, commonly designated and identified as follows:

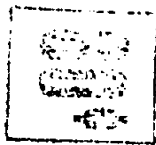
