

ARTICLE EIGHT

Notwithstanding any provision of the Illinois Business Corporation Act of 1983 requiring that any action be taken or authorized by the affirmative vote of the holders of a designated proportion greater than a majority of the shares or votes entitled to be cast, such action shall be effective and valid if taken or authorized by the affirmative vote of the holders of a majority of the total number of shares outstanding and entitled to vote thereon. When shares are voted by series or class, any such action shall be effective and valid if taken or authorized by the affirmative vote of the holders of a majority of the total number of shares of such series or class outstanding and entitled to vote thereon.
