LOAN MODIFICATION AGREEMENT

To renew the said original three (3) year balloon Note and Mortgage now due the LENDER on said January 20, 1987, date for an additional five (3) year at the same terms and conditions as said original Note and Mortgage except that the rate of interest charged hereunder shall be fixed at ten percent (10.0%) for the five (5) year term. The new maturity date is January 20, 1992. The new monthly principal and interest payment will be \$ 514.03.

Except as modified by this Modification Agreement, all of the provisions of the Note and Mortgage shall remain unchanged and in full force and effect.
