ORDINANCE NO. 3726

AN ORDINANCE RENUMBERING CERTAIN LOTS AND BUILDINGS AS WELL AS RENAMING CERTAIN STREETS IN THE VILLAGE OF MOUNT PROSPECT

WHEREAS, the President and Board of Trustees of the Village of Mount Prospect have approved Ordinances annexing certain land and territory to the Village of Mount Prospect; and

WHEREAS, the President and Board of Trustees of the Village of Mount Prospect believe that the change of certain lot and building numbers and the renaming of certain streets is in the best interests of the Village of Mount Prospect.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MOUNT PROSPECT, COOK COUNTY, ILLINOIS:
