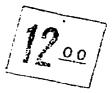

### SECOND MORTGAGE BY A PARTNERSHIP



Noo 20 116 ach 1. JIFFY LUBE REALTY PARTNERSHIP ("Mortgagor"), grants and mortgages to Pennzoil Products Company ("Pennzoil"), P.O. Box 2967, Houston, Texas 77252-2967, all of Mortgagor's interest on real property described below:

## SEE ATTACHED EXHIBIT "A",

also known as 1119 Roosevelt Road, Maywood, Illinois (the "Property"), together with all fixtures and improvements now or later added to the Property.

- 2. This Mortgage is given to secure payment of up to \$6.5 million in obligations incurred by Jiffy Lube of Illinois, Inc. ("JLI"), an affiliate of the Mortgager, pursuant to a January 16, 1987 "Development Agreement" between JLI and Yenzoil, as amended from time to time, the terms of which Development Agreement are incorporated herein.
- The Mortgagor warrants that the Mortgagor owns the Property, and that the Property is unencumbered except by a first mortgage in favor of Skokie Trust and Savings Bank, executed of even date herewith (the "Skokie Mortgage"). The Mortgagor promises not to commit or allow any default under Skokie Mortgage, which is intended to be superior to the mortgage granted herein to Pennzoil, to which this Mortgage is expressly subordinated.
- 4. The Mortgagor promises not to allow any lien or charge with priority over this Mortgage, except for the Skokie Mortgage, to be filed against the Property.
- 5. The Mortgagor promises (a) to keep the Property insured for its maximum insurable value, (b) to nake Pennzoil as an "additional insured" in the insurance policy covering the Property, and (c) to provide Pennzoil with an insurance company's certificate of insurance upon request.
- 6. The Mortgagor promises to keep the Property in good repair and to let Pennzoil's representatives inspect the Property on request.
- 7. The Mortgagor warrants that the Property is used for business purposes and is not a homestead; the Mortgagor provises not to declare the Property to be a homestead.
- 8. In the event that the Mortgagor defaults on any obligation owed to Pennzoil under the Development Agreement or under this Mortgage, Pennzoil Company may foreclose and/or seek any other remedy available under applicable law.
