

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property; trigother with all existing or subsequently erected or affixed buildings, improvements and lixtures, all appurtenances, all rights relating to the real property (including minerals, oil, gas, water, and the like), and all ditch rights (including stock in utilities with ditch or imigation rights) located in Cook County, State of Illino's (ine "Real Property"):

The Westerly half of Lot 1332 in Lines is in Third Division of Riverside in the South half of Section 25 and the North half of Section 36, Township 39 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

The Real Property or its address is commonly known as 402 Longcommon Road, Riverside, Illinois 60548. The property tax identification number for the Real Property is 15-25-410-027-0000.

Grantor presently assigns to Lender all of Grantor's right, title, and houself in and to the Rents from the Real Property. In addition, Grantor grants Lender a Uniform Commercial Code security interest in the Rents and the Fe sonal Property described below.

DEFINITIONS. The following words shall have the following meanings vinon i sed in this Mortgage:

Borrower. The word "Borrower" means Sam A. Lavorato and Patricia L. .avorato. The words "Borrower" and "Grantor" are used interchangeably in this Mortgage.

Grantor. The word "Grantor" means Sam A. Lavorato and Patricia L. Lavorato. The words "Grantor" and "Borrower" are used interchangeably in this Mortgage. The Grantor is the mortgagor under this Mortgage.

Improvements. The word "Improvements" means without limitation all existing and have buildings, structures, facilities, additions and similar construction on the Real Property.

indebtedness. The word "indebtedness" means all principal and interest payable under the Note and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce collections of Grantor under this Mortgage, together with interest on such amounts as provided in this Mortgage.

Lender. The word "Londor" means First American Bank of Riverside. The Londor is the mortgaged under this Mortgage.

Mortgage. The word "Mortgage" means this Mortgage between Granter and London, and includes without limitation all assignments and security interest provisions relating to the Personal Property and Rents.

Note. The word "Note" means that certain note or credit agreement dated 03-05-1987 in the original principal amount of \$12,045.09 from Borrower to Lender, together with all renewals of, extensions of, modifications of and substitutions for the note or agreement together with interest thereon as provided therein. The interest rate on the Note is 5.880%. The Note is payable in 60 Monthly payments of \$260.11. The currently scheduled final payment of principal and interest on the Note will be due on or before 03-20-1992.

Personal Property. The words "Personal Property" mean all equipment, fixtures, and other articles of personal property which by Granter, now or subsequently attached or affixed to the Real Property, together with all accessions, parts, and additions to, all replacements of, and all substitutions for any of such property, and together with all proceeds (including insurance proceeds and refunds of promitims) from any sale or other disposition of such property.

Property. The word "Property" means collectively the Real Property and the Personal Property.

Real Property. The words "Real Property" mean the real property described above in the "Grant of Mortgage" section.

Related Documents. The words "Related Documents" mean and include any promissory notes, lean agreements, guaranties, security agreements, and all other documents executed in connection with this Mortgage or the Indebtedness, whether now or hereafter existing.

Rents. The word "Rents" means all rents, revenues, income, issues, and profits from the Real Property and the Personal Property.

THIS MORTGAGE, INCLUDING THE ASSIGNMENT OF RENTS AND THE SECURITY INTEREST IN THE RENTS AND PERSONAL PROPERTY, IS GIVEN TO SECURE PAYMENT OF THE INDEBTEDNESS AND PERFORMANCE OF ALL OBLIGATIONS OF GRANTOR UNDER THIS MORTGAGE AND IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage, Grantor shall pay to Lender all amounts secured by this Mortgage as they become due, and shall strictly perform all of Grantor's obligations.

POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that its possession and use of the Property shall be governed by the following provisions:

INOFF MONTANGE

Possession and Use. Until in default, Grantor may remain in possession and control of and operate and manage the Property and collect the Rents from the Property.

Duty to Maintain. Grantor shall maintain the Property in first class condition and promptly perform all repairs and maintanance necessary to preserve its value.

Hazardous Substances. Grantor represents and warrants that the Property never has been, and never will be so long as this Dood of Trust remains a lien on the Property, used for the generation, manufacture, storage, treatment, disposal, release or threatened release of any hazardous substance, as those terms are defined in the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. Section 9801, et soq. ("CERCLA"). Granter agrees to indomnify and hold harmless Londer against any and all claims and lesses resulting from a breach of this provision of the Deed of Trust.

Nulsance, Waste. Grantor shall neither conduct or permit any nulsance nor commit or suffer any strip or waste on or to the Property or any portion thereof, including without limitation removal, or alienation by Granter of the right to remove, any timber, minerals (including oil and gas), or soil, or gravel or rock products.

Removal of Improvements. Grantor shall not demolish or remove any Improvements from the Real Property without the prior written consent of Lender. Lender shall consent II Grantor makes arrangements satisfactory to Londor to replace any Improvements which Grantor proposes to remove with improvements of scheat equal value.

Lander's Right to Enter. Lender and its agents and representatives may enter upon the Real Property at all reasonable times to attend to Lender's Interests and to Inspect the Proporty.

Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Granter has notified Londer in writing prior to doing so and Londer's interests in the Property are not joopardized. Lender may require Granter to post adequate security or surety bond (reasonably satisfactory to Londer) to protect Lender's Interest.

Duty to Protect. Grantor shall do all other acts in addition to those acts set forth above in this section, that from the character and use of the Property are reasonably necessary to protect and prosurve the Property.

DUE ON SALE - CONSENT BY LENDER. Lender may r. its option, declare immediately due and payable all sums secured by this Mortgage upon the sale or transfer of all or any part of the Real Property, will out the Londor's prior written consent. A "sale or transfer" means the conveyance of real property or any right, title, or interest therein; whether legal or equirular, whether voluntary or involuntary; by outright sale; dood; installment sale contract; land contract; contract for deed; leasehold interest with a torm greater than throo years; lease-option contract; sale, assignment or transfer of any beneficial interest in or to any land trust holding little to the Real Property; or single other method of conveyance of real property interest. If Granter or any prospective transferee applies to Lender for consent for a transfer, Lender may require such information concerning the prospective transferee as would normally be required from a new loan applicant and may charge a transfer or a sun plion fee not to exceed the amount of the loan fee normally required from a new loan applicant.

TAXES AND LIENS.

Payment. Grantor shall pay when due before they become delinquent all taxes, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of all liens having priority of or equal to the interest of Londer under this Mortgage, except for the lien of taxes and assessments not due, except for the prior indebtedness related to below, and except as otherwise provided in the following paragraph.

Right To Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good faith dispute over the obligation to pay, so long as Lender's interest in the Proporty is not jeopardized. If a lien arises or is filed as a reset of nonpayment, Granter shall within 15 days after the lien arises or, if a lien is filed, within 15 days after Grantor has notice of the filing, secure the discharge of the tion or deposit with Lunder, cash or a sufficient corporate surety bond or other security satisfactory to Lender in an amount sufficient to discharge the lien plus any costs, attorneys' lees, or other charges that could accrue as a result of a foreclosure or sale under the tien. In any contest Granter shall defend itself and Lender and shall satisfy any adverse judgment before enforcement against the Property. Granter shall name Londer as an additional obliged under any surely bond furnished in the contest proceedings.

Evidence of Payment. Grantor shall upon demand furnish to Lender evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lander at any time a written statement of the taxos and assessments against the Progent,

Notice of Construction. Grantor shall notify Lander at least 15 days before any work is commenced, any services are furnished, or any materials are supplied to the Property, if any mechanics, materialmens, or other construction lion could be asserted on account of the work, services, or materials and the cost exceeds \$10,000.00. Grantor will on request furnish to Lender advance assurances satisfactory to Londor that Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE.

Maintenance of Insurance. Grantor shall procure and maintain policies of lire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all Improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. In no event shall the insurance be in an amount less than \$38,000.00. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurer containing a stipulation that coverage will not be carcolled or diminished without a minimum of 10 days prior written notice

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of loss if Grantor fails to do so within 15 days of the casualty. Lender may, at its election, apply the proceeds to the reduction of the indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Granter shall repair or replace the damaged or destroyed improvements in a manner satisfactory to Lender. Lender shall, upon satisfactory proof of such expenditure, pay or reimburse Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default hereunder. Any proceeds which have not been disbursed within 180 days after their receipt and which Lender has not committed to the repair or restoration of the Property shall be used to pay any amounts owing to Lender under this Deed of Trust, then to prepay accrued interest, and then principal of the Indebtedness. If Lender holds any proceeds after payment in full of the Indebtedness, such proceeds shall be paid to Grantor.

Unexpired insurance at Sale. Any unexpired insurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by this Mortgage at any trustee's sale or other sale held under the provisions of this Mortgage, or at any foreclosure sale of such Property.

Compliance With Prior indebtedness. During the period in which any prior indebtedness described below is in effect, compliance with the insurance provisions contained in the insurance provisions under this Mortgage, to the extent compliance with the terms of this Mortgage would constitute a duplication of insurance requirement. If any proceeds from the insurance become payable on loss, the provisions in this Mortgage for division of proceeds shall apply only to that portion of the proceeds not payable to the holder of the prior Indebtedness.

EXPENDITURES BY LENDER. If Granter fails to comply with any provision of this Mortgage, including any obligation to maintain prior indebtodness in good standing as required below, or if any action or proceeding is commenced that would materially affect Lender's interests in the Property, Londor may, at its option, on Granter's behalf take the required action and any amount that it expends in so doing shalf be added to the indebtodness. Amounts so added shall be payable on demand with interest from the date of expenditure until paid at the rate of 10.576% per annum. The rights provided for in this section shall be in addition to any other rights or any remedies to which Lender may be entitled on account of the default. By taking the required action, Lender shall not cure the default so as to bar it from any remedy that it otherwise would have had.

WARRANTY: DEFENSE OF TITLE.

Title. Grantor warrants that it holds merchantable title to the Property in fee simple, tree and clear of all liens and encumbrances other than those set forth in the prior in de techniques section below or in any policy of title insurance issued in favor of, and accepted by, Lender in connection with this Mortgage.

Defense of Title. Subject to the exception in the paragraph above, Grantor warrants and will forever defend the title to the Property against the lawful claims of all persons. In the erion, any action or proceeding is commenced that questions Grantor's title or the interest of Londer under this Mortgage, Grantor shall defend the action at its expense. Grantor may be the nominal party in such proceeding but Londer shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver, or cause to be delivered, to Londer such instruments as may be requested by it from time to time to permit such participation.

Compliance With Laws. Grantor warrants that its use of the Proporty complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

PRIOR INDEBTEDNESS. The following provisions concorning prior indobtedness are a part of this Mortgage:

Prior Lien. The lien of this Mortgage securing the lin obtolines is and remains secondary and interior to the lien securing payment of a prior obligation. In the form of 1st Federal Savings & Loan of Westerstein. The prior obligation has a current principal balance of approximately \$27,000.00 and is in the original principal amount of \$36,000.00. Granter surgesty covenants and agrees to pay or see to the payment of the prior indebtedness and to prevent any default thereunder.

Default. If the payment of any installment of principal or any interest on the prior indebtedness is not made within the time required by the note evidencing such indebtedness, or should an event of default occur under the 'nstrument securing such indebtedness and not be cured during any applicable grace period therein, then the indebtedness secured by this Mortgage shall, at the option of Lender, become immediately due and payable, and this Mortgage shall be in default.

No Modification. Grantor shall not enter into any agrooment with the holder of any mortgage, deed of trust, or other security agreement which has priority over this Mortgage by which that agreement is modified, amended, extended, or renewed without the prior written consent of Lander. Grantor shall neither request nor accept any future advances under a prior mortgage, dood of anst, or other security agreement without the prior written consent of Lander.

CONDEMNATION.

Application of Net Proceeds. If all or any part of the Property is condemned, Londor may at its fraction require that all or any portion of the net proceeds of the award be applied to the Indebtedness. The net proceeds of the award shall mean the next falter payment of all reasonable costs, expenses, and alternays' fees necessarily paid or incurred by Granter, or Londor in connection with the condemnation.

Proceedings. If any proceedings in condemnation are filed, Granter shall promptly notity Lender in writing and Granter shall promptly take such stope as may be necessary to defend the action and obtain the award. Granter may be the nominal party in such proceeding but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Clanter will deliver or cause to be delivered, to Lender such Instruments as may be requested by it from time to time to permit such participation.

IMPOSITION OF TAX BY STATE,

State Taxes Covered. The following shall constitute state taxes to which this section applies: (a) a specific tax upon this type of Mortgage or upon all or any part of the Indebtedness secured by this Mortgage; (b) a specific tax on any Granter which the taxpayor is authorized or required to deduct from payments on the Indebtedness secured by this type of Mortgage; (c) a tax on this type of Mortgage chargeable against the London or the holder of the Note; and (d) a specific tax on all or any portion of the Indebtedness or on payments of principal and interest made by any Granter.

Remedies. If any state tax to which this section applies is enacted subsequent to the date of this Mortgage, this event shall have the same effect as a default, and Lender may exercise any or all of the remedies available to it in the event of a default unless the following conditions are most: (a) Grantor may lawfully pay the tax or charge imposed by the state tax; and (b) Grantor pays or offers to pay the tax or charge within 30 days after notice from Lender that the tax law has been gracted.

SECURITY AGREEMENT; FINANCING STATEMENTS.

Security Agreement. This instrument shall constitute a security agreement to the extent any of the Property constitutes fixtures or other personal property, and Lender shall have all of the rights of a secured party under the Illinois Uniform Commercial Code.

Security Interest. Upon request by Lander, Granter shall execute financing statements and take whatever other action is requested by Lander to perfect and continue Lander's security interest in the Ronts and Personal Property. Granter hereby appoints Lander as Granter's atterney in fact for the purpose of executing any documents necessary to perfect or continue the security interest granted in the Rents and Personal Property. In addition to recording this will be real property records, Lander may, at any time and without further authorization from Granter, file copies or reproductions of this Mortgage as a financing statement. Granter will reimburse Lander for all expenses incurred in perfecting or continuing this security interest. Upon default, Granter shall assemble the Personal Property and make it available to Lander within three days after receipt of written demand from Lender.

Addresses. The mailing address of Grantor (debtor) and the mailing address of Londer (secured party) from which information concerning the security interest granted by this Mortgage may be obtained (each as required by the Illinois Uniform Commercial Code) are as stated on the first page of this Mortgage.

FULL PERFORMANCE. II Grantor pays all of the Indebtedness when due and otherwise performs all the obligations imposed upon Grantor under this Mortgage and the Note, Lender shall execute and deliver to Grantor a suitable satisfaction of this Mortgage and suitable statements of termination of any financing statement on file evidencing Lender's security interest in the Rents and the Personal Property. Grantor will pay, if permitted by applicable law, any reasonable termination fee as determined by Lender from time to time.

DEFAULT. The following shall constitute events of default:

Default on Indebtedness. Borrower fails to make any payment when due on the Indebtedness.

Default on Other Payments. Fallure of Grantor within the time required by this Mortgage to make any payment for taxes or insurance, or for any other payment necessary to prevent filling of or to effect discharge of any lien.

Compliance Default. Failure to comply with any other term, obligation, covenant or condition contained in this Mortgage, the Note or in any of the Related Documents. If such a failure is curable and if Grantor has not been given a notice of a breach of the same provision of this Mortgage within the preceding 12 months, it may be cured (and no event of default will have occurred) if Grantor, after receiving written notice from Lender demanding cure of such failure: (a) tures the failure within 15 days; or (b) if the cure requires more than 15 days, immediately initiates steps sufficient to cure the failure and thereafter confines and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Breaches. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Mortgage, the Note or the Related Documents is, or at the time made or furnished was, false in any material respect.

Termination of Existence. The death of any Grantor (if Grantor is an individual), insolvency of Grantor, appointment of a receiver for any part of Grantor's property, any assignment of the benefit of creditors, the commencement of any proceeding under any bankruptcy or insolvency laws by or against Grantor, or the dissolution of immination of Grantor's existence as a going business (if Grantor is a business).

Foreclosure, etc. Commencement of Prociosure, whether by judicial proceeding, self-help, repossession or any other method, by any creditor of Grantor against any of the Property, however this subsection shall not apply in the event of a good laith dispute by Grantor as to the validity or reasonableness of the claim which is the basis of the foreclosure, provided that Grantor gives Lender written notice of such claim and furnishes reserves or a surely bond for the claim satisfactory to Lender.

Leasehold Default. If the Interest of Grantor in the Property is a leasehold interest, any default by Grantor under the lease, or any other event (whether or not the fault of Grantor) that results in the termination of Grantor's leasehold rights,

Breach of Other Agreement. Any breach by Grantor under the orms of any other agreement between Grantor and Lender that is not remedied within any grace period provided therein, including without limitation engagement concerning any indebtedness or other obligation of Grantor to Lender, whether existing now or later.

Events Affecting Guarantor Any of the preceding events occur with respect to any guarantor of any of the Indebtedness or such guarantor dies or becomes incompetent, unless the obligations arising under the guaranty and related agreements have been unconditionally assumed by the guarantor's estate in a manner satisfactory to Lender.

insecurity. If Lender in good faith deems itself insecure.

Prior Indebtedness. Default of Grantor under any prior obligation or instrument sccuring any prior obligation, or commencement of any suit or other action to foreclose any prior lien on the Property.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any event of default and a any time thereafter, Lender may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate Indebtedness. Lender shall have the right at its option without notice to Grantor to duciero the entire Indebtedness immediately due and payable, including any prepayment ponalty which Grantor would be required to pay.

UCC Remedies. With respect to all or any part of the Personal Property, Londer shall have all the rights and remedies of a secured party under the lillinois Uniform Commercial Code.

Collect Rents. Lander shall have the right, without notice to Granter, to take possession of the Property at disclosed the Rents, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the inclobtedness. In including rence of this right, Lender may require any tenant or other user of the Property to make payments of rent or use fees directly to Lender. If the Rents are collected by Lender, then Granter irrevocably designates Lender as Granter's atterney in fact to endorse instruments received in payment thereof, in the name of Granter and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand an attention this subparagraph either in person, by agent, or through a receiver.

Appoint Receiver. Lender shall have the right to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property proceding foreclosure or sale, and to collect the Rents from the Property and apply the proceeds, over and above the cost of the receivership, against the Indubtedness. The receiver may serve without bond if permitted by law. Lender's right to the appointment of a receiver shall exist whether or not the apparent value of the Property exceeds the Indubtedness by a substantial amount. Employment by Lender shall not disquality a person from serving as a receiver.

Judicial Foreclosure. Londer may obtain a judicial decree foreclosing Granter's interest in all or any part of the Property.

Nonjudicial Sale. If permitted by applicable law, Londor may foreclose Grantor's interest in all or any part of the Personal Property by nonjudicial sale.

Deficiency Judgment. If permitted by applicable law, Lender may obtain a judgment for any deficiency remaining in the Indebtedness due to Lender after application of all amounts received from the exercise of the rights provided in this section.

Tenancy at Will. If Grantor remains in possession of the Property after the Property is sold as provided above or Lender otherwise becomes entitled to possession of the Property upon default of Grantor, Grantor shall become a tonant at will of Lender or the purchaser of the Property and shall pay while in possession a reasonable rental for use of the Property.

Other Remedies. Lender shall have all other rights and remedies provided in this Mortgage or the Note or by law.

Sale of the Property. To the extent permitted by applicable law, Granter hereby waives any and all right to have the property marshalled. In exercising its rights and remedies, Lender shall be free to sell all or any part of the Property together or separately, in one sale or by separate sales. Lender shall be entitled to bid at any public sale on all or any portion of the Property.

Notice of Sale. Lender shall give Granter reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given at least 10 days before the time of the sale or disposition.

Walver; Election of Remedies. A waiver by any party of a breach of a provision of this Mortgage shall not constitute a waiver of or projudice the party's rights officewise to demand strict compliance with that provision or any other provision. Election by London to pursue any remody shall not exclude pursuit of any other remody, and an election to make expenditures or take action to perform an obligation of Grantor under this Mortgage after failure of Grantor to perform shall not affect Landor's right to declare a default and exercise its remodies under this Mortgage.

Afterneys' Fees; Expenses. If Landar Institutes any suit or action to unforce any of the terms of this Mortgage, Landar shall be entitled to recover such sum as the court may adjudge reasonable as atterneys' fees at trial and on any appeal. Whether or not any court action is involved, all reasonable expenses incurred by Landar that in Landar's opinion are necessary at any time for the protection of its interest or the enforcement of its rights shall become a part of the Indebtedness payable on demand and shall bear interest from the date of expenditure until repaid at the Note rate. Expenses covered by this paragraph include, without limitation, however subject to any limits under applicable law, Lendar's atterney fees and legal expenses whether or not there is a laward, including atterneys' less for bankrupicy proceedings (including offens or modify or vacate any automatic stay or injunction), appeals and any anticipated post-judgment collection services, the cost of searching records, obtaining title reports (including foreclesure reports), surveyors' reports, and appraise. Londer requests that copies of notices of foreclosure from the holder of any lien which has priority ever this Mortgage be sent to Lender's address, as hown hear the top of the first page of this Mortgage. For notice purposes, Granter agrees to keep Lender Informed at all times of Grantor's current address.

MISCELLANEOUS PROVISIONS. The following provision are a part of this Mortgage:

Successors and Assigns. Subject to the limitations stated in this Mortgage on transfer of Grantor's interest, and subject to the provisions of applicable taw with respect to successor trustees, this Mortgage shall be bincing upon and inure to the benefit of the parties, their successors and assigns. If ownership of the Property becomes vested in a person other than Grantor, Londer, without notice to Grantor, may deal with Grantor's successors with reference to this Mortgage and the Indebtedness by way of for biarance or extension without releasing Grantor from the obligations of this Mortgage or liability under the Indebtedness.

Applicable Law. This Mortgage has been delivered to Lender in the State of himpis. The law of that state shall be applicable for the purpose of construing and determining the validity of this Mortgage and, to the fullest extent permitted by the law of any state in which any of the Property is located, determining the rights and remedies of Lender on default. The law of the State of Illinois shall control whether the Property may be sold without judicial foreclosure.

Time of Essence. Time is of the assence of this Mortgage.

Waiver of Homestead Exemption. Grantor horoby releases and waives the benefit of the homestead exemption as to all indebtedness secured by this Mortgage.

Merger. There shall be no merger of the interest or estate created by this Mortgage with any other interest or estate in the Property at any time held by or for the benefit of Lender in any capacity, without the written consent of Lender.

Amendment. No alteration or amendment of this Mortgage or the Note shall be effective unless in whiting and signed by the parties sought to be charged or bound by the alteration or amendment.

Caption Headings. Caption headings in this Mortgage are for convenience purposus only and are not to be used to interpret or define the provisions of this Mortgage.

Severability. The unenforceability or invalidity of any provision or provisions of this Mortgage as to any persons or circumstances shall not render that provision or those provisions unenforceable or invalid as to any other persons or circumstances, and all provisions of this Mortgage, in all other respects, shall remain valid and enforceable.

Multiple Parties. If Grantor (including any and all Borrowers executing this Mortgage) consists of more than one person or entity, all obligations of Grantor under this Mortgage shall be joint and several, and all references to Grantor shall mean each and overy Grantor.
