

ASSIGNMENT OF MORTGAGE

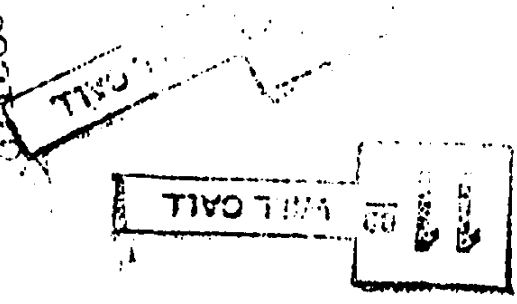
