Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, and the rents, issues, and profits thereof; and all apparatus and fixtures of every kind for the purpose of supplying or distributing heat, light, water, or power, and all plumbing and other fixtures in, or that may be placed in, any building now or hereafter standing on said land, and also all the estate, right, title, and interest of the said Mortgagor in and to said premises.

All insurance shall be carried in companies approved by the Mortgagee and the policies and renewals thereof shall be held by the Mortgagee and have attached thereto loss payable clauses in favor of and in form acceptable to the Mortgagor. In event of loss Mortgagor will give immediate notice by mail to the Mortgagee, who may make proof of loss if not made promptly by Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to the Mortgagee instead of to the Mortgagor and the Mortgagee jointly, and the insurance proceeds, or any part thereof, may be applied by the Mortgagee at its option either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged. In event of foreclosure of this mortgage or other transfer of title to the mortgaged property in extinguishment of the indebtedness secured hereby, all right, title and interest of the Mortgagor in and to any insurance policies then in force shall pass to the purchaser or grantee.

That if the premises, or any part thereof, be condemned under any power of eminent domain, or acquired for a public use, the damages, proceeds, and the consideration for such acquisition, to the extent of the full amount of indebtedness upon this Mortgage, and the Note secured hereby remaining unpaid, are hereby assigned by the Mortgagor to the Mortgagee and shall be paid forthwith to the Mortgagee to be applied by it on account of the indebtedness secured hereby, whether due or not.

The Mortgagor further agrees that should this mortgage and the note secured hereby not be eligible for insurance under the National Housing Act within 60 days from the date hereof) written statement of any officer of the Department of Housing and Urban Development or authorized agent of the Secretary of Housing and Urban Development dated subsequent to the 60th day from the date of this mortgage, declining to insure said note and this mortgage, being deemed conclusive proof of such ineligibility, the Mortgagee or the holder of the note may, at its option, declare all sums secured hereby immediately due and payable.

In the event of default in making any monthly payment provided for herein and in the note secured hereby for a period of thirty (30) days after the due date thereof, or in case of a breach of any other covenant or agreement herein stipulated, then the whole of said principal sum remaining unpaid together with accrued interest thereon, shall, at the election of the Mortgagee, without notice, become immediately due and payable;

And in the event that the whole of said debt is declared to be due, the Mortgagee shall have the right immediately to foreclose this mortgage, and upon the filing of any bill for that purpose, the court in which such bill is filed may at any time thereafter, either before or after sale, and without notice to the said Mortgagor, or any party claiming under said Mortgagor, and without regard to the solvency or insolvency of the person or persons liable for the payment of the indebtedness secured hereby, at the time of such application for appointment of a receiver, or for an order to place Mortgagee in possession of the premises, and without regard to the value of said premises or whether the same shall then be occupied by the owner of the equity of redemption, as a homestead, enter an order placing the Mortgagee in possession of the premises, or appoint a receiver for the benefit of the Mortgagee with power to collect the rents, issues, and profits of the said premises during the pendency of such foreclosure suit and, in case of sale and a deficiency, during the full statutory period of redemption, and such rents, issues, and profits when collected may be applied toward the payment of the indebtedness,

## RIDER TO STATE OF ILLINOIS MORTGAGE HUD-92116M (5-80)

THIS RIDER ATTACHED TO AND MADE PART OF THE MORTGAGE BETWEEN  
Katherine Ellis, MORTGAGOR AND  
NATIONAL HERITAGE MORTGAGE CORPORATION, MORTGAGEE, DATED March 12, 1987  
REVISED SAID MORTGAGE AS FOLLOWS:

1. PAGE 2, THE SECOND COVENANT OF THE MORTGAGE IS AMENDED TO READ:

THAT TOGETHER WITH, AND IN ADDITION TO, THE MONTHLY PAYMENTS OF PRINCIPAL AND INTEREST PAYABLE UNDER TERMS OF THE NOTE SECURED HEREBY, THE MORTGAGOR WILL PAY TO THE MORTGAGEE, ON THE FIRST DAY OF EACH MONTH UNTIL THE SAID NOTE IS FULLY PAID, THE FOLLOWING SUMS:

(A) A SUM EQUAL TO THE GROUND RENTS, IF ANY NEXT DUE, PLUS THE PREMIUMS THAT WILL NEXT BECOME DUE AND PAYABLE ON POLICIES OF FIRE AND OTHER HAZARD INSURANCE COVERING THE MORTGAGED PROPERTY, PLUS TAXES AND ASSESSMENTS NEXT DUE ON THE MORTGAGED PROPERTY (ALL AS ESTIMATED BY THE MORTGAGEE) LESS ALL SUMS ALREADY PAID THEREFOR DEVIDED BY THE NUMBER OF MONTHS TO ELAPSE BEFORE ONE MONTH PRIOR TO THE DATE WHEN SUCH GROUND RENTS, PREMIUMS, TAXES AND ASSESSMENTS WILL BECOME DELINQUENT, SUCH SUMS TO BE HELD BY THE MORTGAGEE IN TRUST TO PAY SAID GROUND RENTS, PREMIUMS, TAXES AND SPECIAL ASSESSMENTS; AND

(B) ALL PAYMENTS MENTIONED IN THE TWO PRECEDING SUBSECTIONS OR THE PARAGRAPH AND ALL PAYMENTS TO BE MADE UNDER THE NOTE SECURED HEREBY SHALL BE ADDED TOGETHER AND THE AGGREGATE AMOUNT THEREOF SHALL BE PAID BY THE MORTGAGOR EACH MONTH IN A SINGLE PAYMENT TO BE APPLIED BY THE MORTGAGEE TO THE FOLLOWING ITEMS IN THE ORDER SET FORTH:

- (I) GROUND RENTS, IF ANY, TAXES, SPECIAL ASSESSMENTS, FIRE AND OTHER HAZARD INSURANCE PREMIUMS;
- (II) INTEREST ON THE NOTE SECURED HEREBY, AND
- (III) AMORTIZATION OF PRINCIPAL OF THE SAID NOTE.

ANY DEFICIENCY IN THE AMOUNT OF ANY SUCH AGGREGATE MONTHLY PAYMENT SHALL, UNLESS MADE GOOD BY THE MORTGAGOR PRIOR TO THE DUE DATE OF THE NEXT SUCH PAYMENT, CONSTITUTE AN EVENT OF DEFAULT UNDER THIS MORTGAGE. THE MORTGAGEE MAY COLLECT A "LATE CHARGE" NOT TO EXCEED FOUR CENTS (4¢) FOR EACH DOLLAR (\$1.) FOR EACH PAYMENT MORE THAN FIFTEEN (15) DAYS IN ARREARS, TO COVER THE EXTRA EXPENSE INVOLVED IN HANDLING DELINQUENT PAYMENTS.

IF THE TOTAL OF THE PAYMENTS MADE BY THE MORTGAGOR UNDER SUBSECTION (A) OF THE PRECEDING PARAGRAPH SHALL EXCEED THE AMOUNT OF THE PAYMENTS ACTUALLY MADE BY THE MORTGAGEE FOR GROUND RENTS, TAXES AND ASSESSMENTS, OR INSURANCE PREMIUMS, AS THE CASE MAY BE, SUCH EXCESS, IF THE LOAN IS CURRENT, AT THE OPTION OF THE MORTGAGOR SHALL BE CREDITED ON SUBSEQUENT PAYMENTS TO BE MADE BY THE MORTGAGOR OR REFUNDED TO THE MORTGAGOR. IF HOWEVER, THE MONTHLY PAYMENTS MADE BY THE MORTGAGOR UNDER SUBSECTION (A) OF THE PRECEDING PARAGRAPH SHALL NOT BE SUFFICIENT TO PAY THE GROUND RENTS, TAXES, AND ASSESSMENTS, OR INSURANCE PREMIUMS, AS THE CASE MAY BE, WHEN THE SAME SHALL BECOME DUE AND PAYABLE, THEN THE MORTGAGOR SHALL PAY TO THE MORTGAGEE ANY AMOUNT NECESSARY TO MAKE UP THE DEFICIENCY, ON OR BEFORE THE DATE WHEN PAYMENTS FOR SUCH GROUND RENTS, TAXES, ASSESSMENTS, OR INSURANCE PREMIUMS SHALL BE DUE.
