NOW, THEREFORE, FNBC hereby declares that the Existing Mortgages and the Existing Assignments and the liens thereof, and all other liens and security interests affecting title to the Property and securing the Existing Notes: (A) are and shall hereafter be subordinate and subject to (i) the New Mortgage and the lien thereof, (ii) the New Assignment, and (iii) all indebtedness evidenced by the New Note or secured by the New Mortgage or the New Assignment (and any amendments of any of them), including without limitation, all disbursements

This Subordiration Agreement shall inure to the benefit of and shall be binding on FNBC and its successors and assigns.
