and in connection therewith and as part thereof, states as follows:
That on and prior to 05/31/86, RALPH C. CAMP and DIANE L. SCHREIBER

was/were the owner(s) of the legally described property which is also commonly known as 702 E APPLETREE Arlington Heights, Illinois, and received and benefited from water service from the Village of Arlington Heights, and continued to receive benefit through the use of said water through 11/30/86 and incurred a total charge of \$ 371.52 from the Village of Arlington Heights, which became due and owing on 01/01/87 by virtue account statements rendered on or before said date; and twenty-one (21) days after said due and owing date, a penalty in an amount equal to ten percent (10%) of said amount was added as a penalty for failure to make prompt payment for a total sum of \$ 408.68 and twenty-one (21) days thereafter, to wit on 02/11/87 said account became delinquent, in accordance with the ordinance of the Village of Arlington Heights.
