

## Excerpts From Internal Revenue Co.

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses \$ pay the same after demand, the amount fincluding any interset, additional amount, addition to tax, or assessable penalty together with any costs that may accrue in addition thereto) shall be a lien in favor of the United States upon all property and rights to preparty, whether risk or personal, belonging to such person.

Sec. 6322: Period Of Lien.

Unless another-date is specifically fixed by law, the lien imposed by section \$321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed for a judgment against the taxpayer arising out of auch lightity) is satisfied or becomes unenforceable by reason of laces of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security In-press, Mechanic's Lieners, And Judgment Lier Creditors. — The Hen Imposed by section 6321 shall not be willed as against any purchaser, holder of a security schenic's liener, or judgment Hen creditor until notice thersel which wests the tadnishments of ansection (i) has reserve medical medical series of an indication that cracket cuts nature. en filler by the Secretary.

## (1) Pipes For Filing Notice; Form.—

Place For Filing - The notice referred to in subection (a) shall be filed -(A) Under State Laws

(i) Real Property - in the case of real property, in one office within the State (or the county, or other governmental subdivision), he designated by the laws of such State; in which the property subject to the lien is situated; and

(iii) Personal Property - in the case of personal property, whether tangible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State. in which the property subject to the fien is silusted;

(B) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to tien is situated, whenever the State has not by law designated one office which meets the requirements of

(g) Refiling Of Notice. — For purposes of this rection placet'

(1) General Rule. — Unless notice of lien is refiled in the manner prescribed in paragraph (2) during the required refilting period, such notice of tien shall be transed as thed on the date or which it is filed (in accordance with subsection (f)) after the expiration of such reliting period.

(a) Release Of Lieft. — Subject to mu regulations as the Secretary may preserbe, the Secretary sho issue a certificate of raiseae of any lien imposed with resp any internal revenue tax not later than 32 days after the day on which -

(1) Liability Satisfied or Unantarceable - The Socretary finds that the Hability for the amount assessed, tegether with all interest in respect thereof, has been fully satisfied or has

become legally unenforceable; or

(2) Bend Accepted - There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment the singust assessed, together with all interest in resp thereof, which the time prescribed by law (including any extension of p ch time), and that is in accordance with such requirements of some to terms, conditions, and form of the band, and suretipe there as, so may be specified by each regulations.
