who are the owners, respectively, of the fee and the leasehold interests in certain real estate and improvements located on property commonly known as 12500 South Stony Island, Chicago, Illinois, and states:

1. That on or about September 16, 1986, the OWNER, LESSEE, 1st SUBLESSEE, and CS&P CO. held ownership and leasehold interests in certain land and/or improvements in Cook County, Illinois, described in Exhibit A, which Exhibit A is attached hereto, incorporated herein by reference and made a part hereof (REAL ESTATE).

That on or about September 16, 1986, as authorized or knowingly permitted by the OWNER and by all previous sub-essors of CS&P CO., SCHERERVILLE STEEL made a contract with CS&P CO., to remove the existing roof on the building of CS&P CO. existing on the REAL ESTATE, and to replace it with a new roof.

3. That said contract to the value of \$79,800 was completed by SCHERERVILLE STEEL on December 31, 1986.

4. That at the special instance and request of CS&P CO., and authorized or knowingly permitted by the OWNER and by all previous sub-lessors of CS&P CO.,
