THIS INDENTURE, made January 9, 1987, between Heritage County Bank of Blue Island as Trustee under Trust Agreement dated July 7, 1983 and known as #2388 a corporation organized under the laws of Illinois, herein referred to as "Mortgagor," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:
