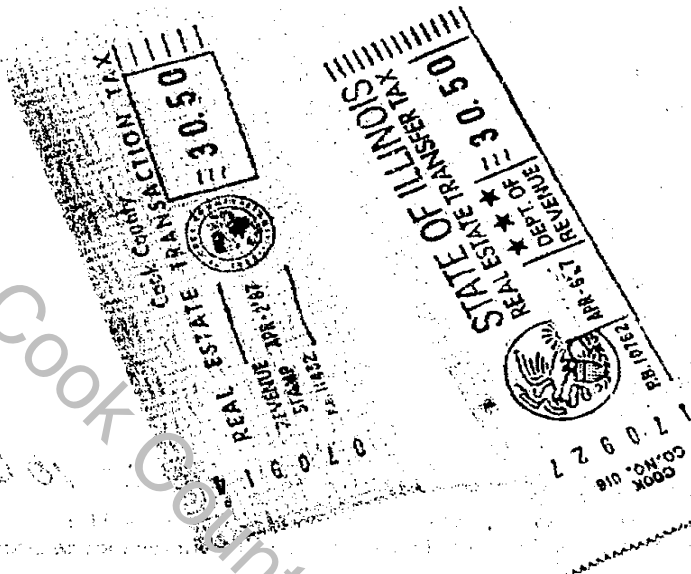

LEGAL DESCRIPTION

Unit #60, together with Garage Space #98, as a limited common element appurtenant thereto in Plymouth Place Condominiums as delineated on a survey of the following described real estate:
