first day of July, A.D., 1922.



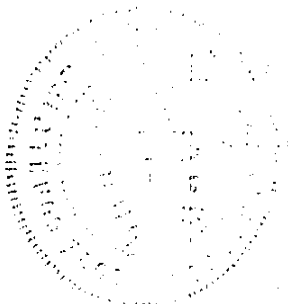
