1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. 8. Inspection. Lender or its agent may make reasonable entries upon and inspections of the Property. Lender

12. Loan Charges. If the loan secured by this Securicy Instrument is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then: (a any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sum, already collected from Borrower which exceeded permitted limits will be refunded to Borrower. CONDOMINUM COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Ler, der further covenant and agree as follows: A. Condominium Obligations. Borrower shall perform all of Borrower's obligations under the Condominium Project's Constituent Documents. The "Constituent Documents" are the: (i) Declaration or any other document which creates the Condominion, Project; (ii) by-laws; (iii) code of regulations; and (iv) other equivalent documents. Unless Borrower and Lender agree to other terms of payment, these amounts shall bear interest from the date of disbursement at the Note rate and shall be payable, with interest, upon notice from Lender to Borrower requesting payment.
