- 6. Upon, or at any time after the filing of a bill to foreclose this Trust Deed, the court in which such hill is filed niely appoint a receiver of said premises. Such appointment may be made either before or after sale, without regard to the solveney or his elveney at the time of application of such receiver, of the person or persons, if any, liable for the payment of the indebtedness secured hereby, and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit, and in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further time when First Party, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. Without the advanced written consent of the holders of the Note, First Party does further coverant and agree that it will not transfer, convey or cause to be transferred or conveyed or suffer an involuntary transfer or conveyance of the premises of the eneficial interest in the trust holding title to the premises, including the transfer of possession of the premises pursuant to the sale thereof under achieva of agreement for the issuance of a Warranty Deed, or otherwise, so long as the debt secured hereby subsists, and further, in the event of any sach transfer by the First Party without the advanced written consent of the holders of the Note, the holders of the Note, in their sole discretion, and wi soit notice to the First Party, may declare the whole of the debt secured hereby immediately due and payable and such transfer or conveyance null and soit.
