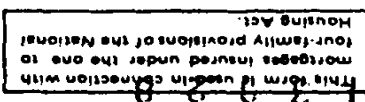

IN THE EVENT of default in making any mortgage payments provided for herein and in the note secured here- by for a period of thirty (30) days after the due date of any such payment, then the whole of the principal sum remaining unpaid together with accrued in- terest thereon, shall, at the election of the Mortgagee, become immediately due and payable.
