It is understood and agreed, however, anything herein contained to the contrary notwithstanding, that until default shall be made by the party of the first part in the promt and faithful performance of any of the terms, covenants and conditions om said Trust Deed and the principal note thereby secured contained, that the party of the first shall have the right to retain possession of said above described real estate and of the building and improvements thereon and to collect and retain the rents, issues and profits thereof.

This agreement shall remain in full force and effect during the terms mentioned in said Trust Deed and during the period of any extension of the not secured by said Trust Deed, until such time as the note secured by said Trust Deed shall be full paid.
