DELINQUENT WATER SERVICE

The Claimant, VILLAGE OF LYONS, a Municipal Corporation organized and existing under the laws of the State of Illinois, in the County of Cook and State of Illinois, hereby files a claim for delinquent water service charges on the real estate hereinafter described and states:

1. A description of said real estate is as follows:

NORTHWEST OF SECTION 1-38-12, REAL ESTATE INDEX #18-01-100-005-
7942 Ogden Ave., Lyons, Ill. Y
2. The amount of the Delinquent Water Service charge is the sum of \$ 2,707.13 6-7
3. The date when said water service charge became delinquent is February 1, 1987.
4. The owner of said real estate refused or neglected to pay the water service charges established by ordinances of the Village of Lyons, for water and sewer services provided by the Claimant, Village of Lyons, pursuant to authority given by the laws of the State of Illinois (Illinois Revised Statutes 1985, Chapter 24, Section 11-139-8) and the Ordinances of the Village of Lyons (Section 5-1-5 of the Revised Code of Lyons of 1965 as amended) and the charges became delinquent on the date hereinbefore set forth which date was not less than thirty (30) days after a bill was rendered for said water service.

WHEREFORE, said Claimant, Village of Lyons hereby claims a lien upon said real estate hereinbefore described, as provided by law.
